Re: Land Use at Comparable Reservoirs

In response to the question "What are other cities doing with use around their reservoirs?" I surveyed a dozen Virginia localities for comparable situations. I did not look at the most populous areas (Richmond, Hampton Roads, Fairfax) because they tend to draw either directly from rivers and/or from the ground.

I looked at the following: Roanoke City / County; Lynchburg; Fredericksburg / Spottsylvania; Charlottesville / Albemarle; Stafford County; Harrisonburg / Rockingham; Danville; Montgomery County (Blacksburg); Martinville; Culpeper; Manasas; Winchester and Staunton and I did find some analogous situations, though nothing exactly like Ragged Mountain, which (like all of them) is a unique property.

Those areas that have reservoirs with adjacent public lands tend to manage them in a way that is quite like the Forest Service's approach. Indeed, several of them (Lynchburg, Harrisonburg and Roanoke) are located in National Forests.

In terms of Land Use, that means hiking, jogging and leashed dogs are allowed (though not in the water). No large area I've found outside of the Charlottesville MSA even mentions jogging in its rules. Bicycles are prohibited in two of the areas (Lynchburg and Harrisonburg) and permitted in four of them (Roanoke, Spottsylvania, Martinsville and Staunton). The others are private land or rivers, which are not really controllable. Those areas that allow bikes have certain trails where they are allowed and others where they are not.

Most of the reservoirs (not Manasas¹ or Staunton) allow boats, with regulation. Those that allow motors must be electric. Besides toxic pollutants water authorities are also very wary of Zebra Mussels. This aquatic invasive spreads easily but appears to be controllable by only permitting boats that are permanently on site or private ones that are cleaned of vegetation and allowed to dry for a week prior to launch. I have included a National Parks Service document about that.

Two of the areas (Roanoke and Staunton) allow horses, with restrictions. None permits swimming.

I was asked by a citizen at the February 29 presentation to be sure to look at off-stream reservoirs. Whether the reservoir water comes from its own watershed or is piped in does not appear to have any impact on surrounding land use decisions. That is not a surprise because off-stream reservoirs often get their water from unprotected watersheds.

¹ In the case of Lake Manasas, there is controversy about whether this prohibition is related to Homeland Security or protecting exclusive private property that surrounds it.

For the sake of curiosity, I looked at some college towns around the country for out-of-state analogues, and that proved surprisingly difficult. Most towns of our size either pull water directly from rivers or from wells. In the interest of time, I curtailed the search after five: Asheville, Athens, Boulder, Durham and State College. They vary from being completely closed to the public (Asheville) to partially surrounded by homes (Boulder) with land use only controlled by zoning. In any case there are not enough analogues in my quick search to conclude that Virginia is particularly unique.

I have not bothered to investigate lakes that are not reservoirs because they will almost certainly be less restrictive than the most permissive regime that one could envision at Ragged Mountain.

The most germane models seem to be Carvins Cove (Roanoke) and Pedlar Reservoir (Lynchburg).

Carvins Cove is explicitly intended as an accessible (though natural) amenity. All of the uses contemplated at Ragged Mountain are permitted, even actively promoted there. Roanoke's approach to protecting its water supply is much more focused on protecting its watershed than about prohibiting access the reservoir. They have a detailed Natural Area Management plan and a Trail Management plan, which I have requested for you. I've attached their rules and trail map. Pedlar Reservoir is a beautiful site and is considered quite pristine. It is very secluded, accessible only by Forest Service road and the Appalachian Trail. That is why bikes are not allowed—because there's no place for them to go—not because they're forbidden from the land (remember: it's Forest Service). Pedlar has its own set of boats that anglers may use but the area is not specifically designated for human use and although not closed it is not particularly accessible or close to town. All twelve of the Virginia water sources and the five out-of-state are summarized on the below grid.

It is important to note that the reservoirs on this grid represent reservoirs that "are"—full stop. We do not know whether they were wise choices or whether the particulars of each city and site are translatable to Charlottesville's situation. It is a basic maxim of land use that every plot is unique and while we can learn some things from the experiences of others, Charlottesville will need to decide what is best for *this* piece of land.

I could imagine a few areas of further investigation if it is deemed necessary and if my other responsibilities permit:

- 1. Survey more towns outside of Virginia, though I deem it unlikely that a unifying pattern will emerge that is different than Virginia.
- 2. Survey areas specifically designated as "natural areas" that may or may not have water bodies. If the RMNA is deemed to be entirely sensitive, then less intensive models will be necessary.
- 3. Follow up with Lynchburg and Roanoke and dig deeper into their original plans and subsequent evaluations.
- 4. If a certain mix of uses is approved, we can look at the *tactically* best practices of implementation.
